No Miscellaneous Updates for October 2018

A. EPA Electronic-Manifest System: Update

On October 31, 2018, the Environmental Protection Agency (EPA) hosted a webinar updating e-Manifest users on upgrades that EPA is working on for the e-Manifest System and announcing that the e-Manifest public data would be available on the RCRAInfo Web beginning on November 1, 2018.

Summary

No paper manifests submitted to EPA (paper manifests mailed to EPA or manifest images submitted to the e-Manifest system) have been processed. EPA is working with the paper processing center to catalog and batch manifests for upload and data entry.

The following functionalities are in development:

1. The ability for a broker to prepare a manifest for a generator
2. The ability for a transporter to create a manifest

EPA is in the process of compiling a list of wastes required to be manifested by states. EPA hopes to have this available on-line by the end of the year.

On November 1, 2018, EPA will begin making e-Manifest data available to the public on RCRAInfo. This information will be updated once per week by EPA and includes the manifest number, EPA ID Number and name of all sites reported on the manifest, number and type of containers, waste codes, management method codes, and quantity. This information is published 90 days after receipt by EPA.

B. EPA Fall 2018 Regulatory Agenda

In October 2018, the Department of Transportation, Federal Motor Carrier Safety Administration (FMCSA) and the Pipeline and Hazardous Materials Safety Administration (PHMSA) published the Fall 2018 Semi-Annual Regulatory Agenda as part of the 2018 Fall Unified Agenda and Regulatory Plan.
