Veolia ES Technical Solutions, L.L.C. (Veolia) located at 125 Factory Lane, Middlesex, NJ 08846 has filed an application to renew and modify our main facility operating permit with the New Jersey Department of Environmental Protection (NJDEP).

This Facility was first established in 1962 and has undergone multiple permit renewal cycles since that time. The facility was purchased by Veolia in 2007. The current Part B was issued on September 30, 2014 and the renewal application was submitted on April 30, 2019 in compliance with the regulatory timeframes. A draft permit renewal was issued by NJDEP on August 5, 2022. Upon final approval the permit will be renewed for an additional ten (10) years.

Two permit modifications have been included in the draft Part B renewal. The first modification is in regard to a request to increase total hazardous waste container storage capacity from 557,000 gallons to 612,000 gallons. The second modification regards a request for an increase in storage time for loaded tankers and trailers containing hazardous or non-hazardous wastes in the receiving area of the plant from 24 to 72 hours prior to moving them into the main facility for processing.

The Veolia Middlesex facility specializes in recycling waste solvents for reuse by industry and blending waste organic liquids such as paints, solvent, oils, polymers, etc. into fuel that is used to offset gas and fuel oil usage at cement manufacturing facilities. In 2022 Veolia Middlesex recycled over 51,000 tons of waste solvents and other organic liquid wastes in a safe and compliant manner.
